Guidelines and measures to prevent the spread of COVID-19 for attendees of the 2021 Annual General Meeting of Unitholders

2. In the event that unitholders wish to attend the meeting in person, or grant a proxy to any other person to attend the meeting

The Company has arranged for screening points in accordance with the practice of the Department of Disease Control. The Company reserves the right to refuse attendance to unitholders or proxies with a body temperature of higher than 37.5 degrees Celsius and/or with respiratory symptoms. Unitholders are able to grant a proxy to the independent director of the Company.

At the venue, the Company has arranged for hand washing facilities and distancing of seats in compliance with the measures to prevent and control the spread of COVID-19. The Company requests unitholders and proxies attending the meeting to wear face masks at all times when attending the meeting.
